RULES AND REGULATIONS

1. The Superintendent must be notified of burial before arrangements are made. The family of the deceased or the funeral director must indicate where the grave is to be opened. Unless these conditions are met, the Cemetery Association will not be responsible for mistakes.
2. At least forty-eight (48) hours notice must be given to dig all graves unless otherwise required by law. This notice may be waived by the Superintendent.
3. All foundations for monuments and headstones shall be placed in the cemetery by, or under the supervision of the Superintendent.
4. No monument with a base larger than 3'10" x 1'2" will be permitted on a lot. The placement of the monument is to be determined by the Superintendent of the cemetery. All headstones or grave markers must be flush with the ground. The Superintendent must be notified before arrangements are made for any monument, stones, or marker to be placed in the cemetery. No monument will be allowed to be delivered to the cemetery until the foundation is installed and ready to receive the monument.
5. No vault or mausoleum shall be built above ground without the permission of the Trustees of the cemetery, and then only in such location as they may approve. No such vault or mausoleum will be approved for construction unless a sufficient endowment is set up to provide adequate income to maintain the structure.
6. The Stillwater Cemetery Association reserves the right to remove, after due notice to the owners of the lot, any monument, effigy, or inscription which, in the opinion of the majority of the trustees, is unsightly or dangerous.
7. No trees or shrubs are to be planted on lots. Annual flowers are to be set adjacent to the monument. Lot owners will be responsible for trimming around and care of such annual flowers.
8. The Stillwater Cemetery Association reserves the right to remove any and all flowers, flags, wreaths, or other decorations from lots as soon as they become unsightly. The Association shall also retain the right to remove all floral designs, flowers, trees, shrubs, decorations of any kind, evergreens, and plants of any kind, from the cemetery lots if, in the judgment of the management, they do not conform to the standard maintained by the cemetery.

9. No urns other than those currently being used will be permitted on graves. Urns must be placed so as not to interfere with the passage of equipment.

10. Fences, hedges, curbing, iron or wire work, seats, steps, posts, raised or lowered lots are prohibited, except for those already existing. This rule may be waived upon approval by the Board of Trustees of written application and description of the waiver sought furnished to the Superintendent.

11. Members of the immediate family of the lot owners may care for their own lots at their discretion and at their own risk, and to the extent that they do not violate any of the cemetery rules and regulations, or affect adjoining lots. Those who do care for their own lots are requested to deposit all of their rubbish at a place designated for the purpose.

12. All funerals, processions, and vehicles will be under the control of the Superintendent while in this cemetery. Heavy trucking or other vehicular traffic shall be refused entrance to the cemetery when, in the opinion of the Superintendent, injury to roads and driveways might result.

13. Graves will not be opened between November 1 and May 1, if, in the judgment of the Superintendent, frost or weather conditions prohibit the same.

14. All lot owners are required to notify the cemetery of any change of address. All notices required to be sent shall be sent to the last recorded address and such notice shall be deemed adequate.

15. Disinterments will be allowed between 9 A.M. and 3 P.M. on weekdays provided the provisions of Section 1510(F) of the Not-for-Profit Corporations Law are complied with.
